• Mr. Jayanta De (BDO, Goghat-2):

Mr. De focused on the *Demerits of Ragging* and shared practical ways to prevent it. He spoke about how ragging negatively impacts both the victims and perpetrators, often hindering students' academic progress. He also stressed the importance of focusing on their education and future careers, rather than engaging in harmful activities.
