**MEMORANDUM OF UNDERSTANDING**

**Between**

**Asia in Global Affairs, Kolkata**

**And**

**Sri Ramkrishna Sarada Vidya Mahapitha, Kamarpukur Hooghly**

**Background**

In order to achieve a successful and sustainable partnership, Asia in Global Affairs (AGA) and Sri Ramkrishna Sarada Vidya Mahapitha, Kamarpukur Hooghly

endorse this Memorandum of Understanding.

Both organisations will make every reasonable effort to encourage educational and research and development, cooperation and will endeavour to cooperate in the fields with which both organisations are concerned. Within spheres that are mutually agreed to, these organisations agree on the following general forms of cooperation:

## **Administration**

Each organisation has assigned an individual authorized to be responsible for the administration and evaluation of this MOU as follows:

- Provide learning opportunities at Asia in Global Affairs for students
- Explore the possibility of placement of students for internship and on live projects
- Share academic infrastructure such as library, workshops and so on;
- Conduct joint research with faculty/experts from both organisations, and joint publication;
- Organise other academic and professional enhancement activities from time to time, which are of mutual benefit.
- Sri Ramkrishna Sarada Vidya Mahapitha, Kamarpukur Hooghly may also invite experts from Asia in Global Affairs for teaching various courses offered by University, after fulfilment of educational and experience requirement as per University norms.

## **Financial Considerations**

Financial arrangements and details for the activities undertaken by the parties pursuant to this MOU shall be determined by the parties, and shall be in writing and signed by all parties. This MOU does not impose any financial liability or responsibility on either organisation with respect to the costs or expenses of the other.

## **Confidential and Proprietary Information**

Prior to the exchange of any information between the organisations of a confidential or proprietary nature under this MOU, the organisations will each execute and deliver to the other a mutually agreeable confidentiality and non-disclosure agreement.

## **Publicity**

All publications and publicity, regardless of media, with respect to this MOU require the expressed written consent of the other party prior to being issued.

Any notices or approvals required to be given by the organisations under this MOU will be sent to the others by registered mail, email, facsimile, or by personal delivery to the above organisations.

### **Term, Renewal, Termination and Amendment**

This MOU shall become effective on the date of signing. The two organisations plan to review this MOU after two year of inception, and thereafter at five year intervals. Any party may opt out of this MOU at any time by mutual consent or by notice in writing upon the mutual consent of the parties.

### **MOU Status**

This MOU specifies general areas of potential exchange and cooperation and merely sets out the general basis upon which the organisations intend to proceed.

This MOU is a non-binding agreement between the organisations and does not commit the organisations to enter into any binding or legal arrangements or agreements.




