Memorandum of Understanding for Academic and Cultural Cooperation

and

Sri Ramkrishna Sarada Vidyamahapitha, Kamarpukur, Hooghly (here afterwards SRSVM) and Dr. Bhupendra Nath Dutta Smriti Mahavidyalaya, Hatgobindapur, Purba Burdwan (here afterwards BNDSM) wish to initiate collaboration in different disciplines through various programmes supported by the two institutions.

SRSVM and BNDSM recognize their strengths in education in the discipline of Science and Arts and their mutual interest in engaging themselves in academic as well as cultural cooperation.

Therefore, SRSVM and BNDSM agree to establish a programme for academic and cultural co-operation in areas of mutual interest, and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU).

D. Students Exchange

SRSVM and BNDSM agree to discuss the means for enabling the exchange of students between two institutions. Each exchanged student would be selected by mutual agreement and in accordance to the regulations of the partner institutions.

E. Tenure and Termination

This MoU will take effect from the date it is signed by Principal of the two institutions. It will remain valid for a period of five years. This MoU will be reviewed after three years; the terms of this MoU may be amended by mutual written agreement prior to the date of review. Any extension to this MoU will be formally approved in writing by the parties. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither SRSVM nor BNDSM will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, SRSVM and BNDSM will ensure that all activities in progress are allowed to complete successfully.

F. Arbitration clause

If there be a dispute relating to any aspect of academic and cultural co-operation, Principals of both institutions will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
